GET FREE UTILITY ASSISTANCE WITH LIHEAP

Rising heating and electric bills can create a burden on any family. The Low-Income Home Energy Assistance Program (LIHEAP) helps eligible lowincome households with their utility bills. Qualified residents can receive a utility bill credit based on the size and income of the household and can apply for free with a Township staff member. This November 8, a referendum to create a Community Mental Health Board (708 Board) for the Township of Schaumburg will be on the general election ballot. If adopted, a volunteer 708 Board will conduct a needs assessment and oversee the distribution of funds for local services relating to mental health, substance use disorders and developmental disabilities for Schaumburg Township residents. There are nearly 100 such Boards in Illinois as allowed by the Community Mental Health Act, including neighboring Hanover and Bloomingdale Townships. WHEN TO WORRY ABOUT PERSISTENT UTIS

Urinary Tract Infections (UTI) are one of the most common types of infections. Symptoms of UTIs can be alarming and can include:

- Pain, burning or stinging when you use the restroom
- Overactive bladder and uncontrollable leakage
- Passing frequent, small amounts of urine
- Cloudy urine, blood in your urine or urine that is red or pinkish
- Urine with a strong, foul odor

If you are experiencing these symptoms, contact your doctor for testing and treatment. In older adults, the symptoms can look different and can even present as confusion or disorientation. If a senior suddenly seems confused in a matter of days, contact their physician. Nurse Janet Stachula is at the Township of Schaumburg offices Tuesday -Thursday from 8:30-4pm and can share resources on health and wellness. UTIs and other health issues are often covered in her free monthly Coffee and Conversation classes every 1st Wednesday of the month at 9am at One Illinois Blvd, Hoffman Estates. MEDICARE OPEN ENROLLMENT OCTOBER 15 - DECEMBER 7

Medicare Open Enrollment occurs every October 15 - December 7, wherein recipients may enroll, change or disenroll from their Part C (Advantage) plan or change their Part D (prescription drug) plan. Plans get added and changed every year - if you have increased costs or have non-covered prescription drugs, it could be worth reviewing options. The Township has several Senior Health Insurance Program (SHIP) counselors who can provide free, unbiased Medicare information and education. Appointments can be made at 847-285-4541 and are required. Phone appointments and limited evening appointments available. You can also call 800-MEDICARE or the State of Illinois SHIP Hotline at 800-252-8966 for assistance. We look forward to assisting you!

AARP INCOME TAX ASSISTANCE

Each year the Township partners with AARP to provide FREE income tax assistance. AARP Tax Aide helps low- to moderate-income taxpayers file their state and federal returns. Appointments are typically available from early February - April. Call the Township's AARP Tax Aide Direct Line 847-285-4597 starting January 24 to schedule an appointment. Appointments are required and will be scheduled in date-order. Participants are required to have



all documentation needed to process your taxes before calling to schedule an appointment. Due to COVID-19, this program is subject to change. SHORTER PASSPORT PROCESSING TIMES

In September the U.S. Department of State announced shorter processing times for passport applications. Standard processing is now 7-10 weeks, and expedited processing is available at 4-6 weeks for an added \$60*. The Township Passport Office is open Monday-Friday from 9-4pm. People experiencing a mental health or substance use crisis now have a way to connect with local crisis counselors by calling or texting 988, the Suicide & Crisis Lifeline. SERVICES FOR UNINCORPORATED RESIDENTS

Did you know the Township offers a variety of services to Unincorporated Cook County residents in the Township that mirror some municipal services to incorporated residents? For example, the Township manages the garbage and recycling contracts for unincorporated Cook County residents in the Township and the Road and Bridge District staff maintain many unincorporated roads, including snow plowing in these areas. Unincorporated Township residents only need to get permits from the Township for certain construction projects such as new homes, additions and driveways. For other construction, unincorporated residents may have to reach out to the county for additional permits.



FROM THE DESK OF THE HIGHWAY COMMISSIONER: SCOTT M. KEGARISE

Fall has arrived and with the change of weather comes new challenges for your road district - snow, ice, wet leaves and general slippery conditions. Please remember over-salting has a deleterious effect on our environment and wildlife.

During this past summer several anonymous letters were submitted to the Township Road District regarding property conditions. First an understanding of Road District responsibility can be helpful to understanding our response. The Road District is responsible for 33 feet from centerline. We are not able, without the property owner's authorization, to venture further onto one's property. If a yard is overgrown our only option after cutting the right of way is to notify the owner to perform the maintenance. Failure of the property owner to comply will subsequently result in notification to the ordinance department of Cook County.

Neither the Township or Road District have a code enforcement officer, nor an ordinance related to grass height for unincorporated residents.

The anonymous writer of the complaints assumes that nothing was done regarding their issues and further chides elected officials for their supposed do-nothing attitude. Because the writer failed to sign their complaint, we could not notify them of the resolution. Not only were the issues addressed but a considerable amount of time by three agencies was spent in an attempt to resolve them. COOK COUNTY BOARD OF REVIEW APPEALS

Township residents will be able to appeal their property taxes a second time during the Cook County Board of Review Residential Property Tax Appeals period, typically held at the end of the year. Residents can appeal with the Board of Review regardless of previous reductions with the Cook County Assessor's Office or previous lack of comparable properties. The Township Assessor's Office can help process appeals electronically and in person once the appeals period begins. A MESSAGE FROM SUPERVISOR TIM HENEGHAN

As the Township closes out another incredible year of service to our residents, I'd like to take a moment to reflect on some recent building projects and look ahead to some we have planned in the coming year. The Township recently updated our HVAC system and roof to improve efficiency throughout the building. Our LED lighting project is also slated to be completed within the next year, which will save the Township thousands of dollars a year in lighting costs. Environmentally, we can expect an annual reduction of 38 metric tons of CO₂ from the project - that's the equivalent of taking 8 cars off the road annually. The Township is undertaking a lobby renovation project, which will create a more functional, inviting and safe space for our residents and staff. Following this summer's community assessment, the Township Board of Trustees will roll up our sleeves to formulate a thoughtful strategic plan - setting in motion the future of service in the Township. This year will bring many changes but will create a healthier environment as well as increase cost savings to be used on more services to our most vulnerable neighbors.
