

**MINUTES SPECIAL MEETING OF TOWNSHIP ELECTORS
OF THE TOWNSHIP OF SCHAUMBURG**

**WEDNESDAY, OCTOBER 19, 2022
7:00 P.M.**

**Vernon A. Laubenstein Schaumburg Township Town Hall,
One Illinois Boulevard, Hoffman Estates, IL 60169**

I. Call to Order

The meeting was called to order by Town Clerk W. Robert Vinnedge at 7:00 p.m., with 59 electors of the Township of Schaumburg present.

Clerk Vinnedge asked everyone to join him in the pledge of Allegiance

II. Election of Moderator

Clerk Vinnedge asked for nominations for a Moderator to be responsible for overseeing the meeting. Elector Scott Kegaris nominated Douglas Kettel to serve as Moderator. This nomination was seconded by Elector Rich Del Boccio. No other nominations were made. On the call for a vote by show of hands on the motion to elect Douglas Kettel as Moderator, with 59 in favor and none opposed, Douglas Kettel was elected as Moderator for the special Town meeting.

III. Swearing in of Moderator

Clerk Vinnedge administered the Oath of Office to Moderator Douglas Kettel and turned the meeting over to Moderator Kettel.

IV. Moderator Kettel stated that the Township electors are being asked to adopt an ordinance electing participation of the Township of Schaumburg, in the Illinois Municipal Retirement Fund, including in such participation, the Road District and all other bodies politic heretofore or hereafter established by, or subject to the direct or indirect control of the Township Electors.

Moderator Kettel then read the following Ordinance into the record, as follows:

AN ORDINANCE ELECTING PARTICIPATION OF A TOWNSHIP IN IMRF

BE IT ORDAINED by the Electors of the Township of Schaumburg, that:

WHEREAS, at the annual town meeting, the electors authorized the town supervisor to file an application on behalf of the town to participate in the Illinois Municipal Retirement Fund; and

WHEREAS, the application of the town has been filed with and approved by the Board of Trustees of the Illinois Municipal Retirement Fund; and

WHEREAS, the town, by adoption of the Electors of an Ordinance may elect to participate in the Illinois Municipal Retirement Fund to begin on the 1st day of January following the adoption of the Ordinance and filing of the Ordinance with the Board of Trustees of the Illinois Municipal Retirement Fund; and

WHEREAS, the election to participate in the Illinois Municipal Retirement Fund is irrevocable and participation will continue as long as the town exists; and


NOW, THEREFORE, BE IT ORDAINED by the Electors of the Township of Schaumburg, Cook County, Illinois, that said town and all other bodies politic, heretofore or hereafter established by, or under direct or indirect control of the electors, shall participate as a single municipality in the Illinois Municipal Retirement Fund, so that participation will be effective on January 1, 2023.”

After reading the Ordinance, Moderator Kettel asked for a motion to approve the Ordinance as read. Elector Scott Kegarise made the motion to approve the Ordinance as read. Elector Charlotte Kegarise seconded the motion. Moderator Kettel asked for discussion on the motion. After seeing no discussion on the matter, Moderator Kettel called the vote on the motion to approve the ordinance and by show of hands, with 59 in favor and 0 opposed, the motion carried and the ordinance was approved.

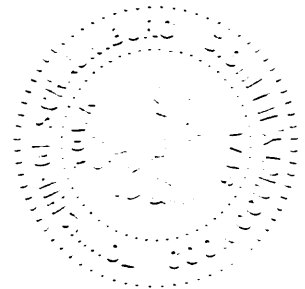
- V. Moderator Kettel then asked for public comment. No public comment was made.
