  - a. Funded Agency Grant Application Review
    - i. Clearbrook Center Requested \$25,000to support the operation of Clearbrook's Residential, Day and Early Intervention programs and delivery of services.
    - ii. Clearbrook Partners in Adult Learning Requested \$1,000 for the support of the PAL program.

- iii. Little City Foundation Requested \$19,630 for the support of adult day services programs.
