- A. Northwest Cook Transit Coordination Study on providing transportation for students going to and from Harper College is requesting the Township to sign a resolution stating we would cooperate with a CMAP study to gather data on needs.

All routes were measured to be sure the buses would work without needing an additional charge. We are looking at 5 charging stations which would power 2 buses each, and 2 public facing stations for community use.
- C. The board discussed the 10 Year Efficiency Study which is required by the State. Their first meeting on completing this process will be on June 10th at 6pm. The study should consist of all of the board members and 2 residents.

- **D.** Administrator Williams and Human Resource Coordinator Lizcano provided an update on the transition of moving payroll to Paylocity. There have been several bumps in the process, but we are all working through them. The Administrator complimented Coordinator Lizcano for taking over such a large challenging job.
- E. Staff Appreciation Luncheon will be held on June 23rd at Chandlers restaurant. The leadership team will work together to come up with some team building games. All departments plan to work toward to win the trophy from the Disability and Seniors Department, last year's winners.
