Highway Commissioner Kegarise stated he had cut \$20,000 from his salary budget. However, he left the overtime close to the same not knowing how many hours his employees would be out on the roads after regular business hours. The discussion then focused on salaries for the Township budget. After a lengthy discussion with various recommendations, there was still no agreement upon salary increases or COLA chosen. Also, a brief discussion suggested the possibility of considering a sliding scale for a bonus if it was well deserved. However, finally it was agreed to request Accountant James Howard to work up three different salary permutations for the board to consider for selection and approval at the next board meeting.
